Please note - Applications close on Friday 24th January 2025. Sites are not allocated on a first in basis but on what the committee thinks is the best fit for the market.

Please note - Cost per site is \$75. Do not send money with your application. Payment is not required until your application has been approved.

TERMS AND CONDITIONS

(Before applying for a site, please read the following)

- We will **not** be offering any powered sites. You will need to provide your own generator if you require power. Generators must be quiet and free of fumes.
- This is a waste free event. Decisions on allocation of sites will be heavily influenced by the stall holder's ability to be waste free.
- Vehicles may enter the market area for setting up purposes ONLY from 6:30am on the day of the market. All vehicles **MUST BE REMOVED FROM MARKET AREA BY 8:00AM.**
- Each site is 5m x 3m. **This means that a 6m or 2x3m gazebos will not fit on one site.**
- The Folk Festival Community Market is run, managed, and organised by volunteers. As such, understanding, courtesy and respect must be shown to all volunteers, at all times. Failure to do so may result in a site booking being cancelled or stallholders being asked to vacate their site on the day of the market.
- The organisers reserve the right to make decisions about site allocations with the aim of promoting a successful market. These decisions will not be negotiable or discussed. Please note that the township of Yackandandah is located in an undulating area, therefore most sites will be situated on sloping ground. Please be prepared for this eventuality.

- On the day of the event, our volunteer marshals will be unable to reassign site allocations, nor will they be able to negotiate with stallholders regarding position or size of site. Again, any discourteous or aggressive behaviour toward our volunteers will not be tolerated.
- The organising committee takes no responsibility for inclement weather. Site fees will not be returned due to weather conditions. The organising committee retains the right to return any application fee or reject any application and in such an instance, no correspondence will be entered into
- Further details will be sent to you when the market has been finalised, along with a receipt for your site fee.

SPECIAL INFORMATION FOR FOOD VENDORS

- All food providers at the Folk Festival need to register with their local council for 2025 (registration now covers the whole state) and provide a Statement of Trade to Indigo Shire at least 14 days before the market. The address is as follows:
